Reading through the letters of Saint Paul it is clear that he is a master on using metaphors. Actually, one of his main ways to communicate ...¹ Paul's letters were written in order to persuade his audience of the powerful truth of the gospel that he learned from Christ himself. As such Paul is called to preach the crucified Christ in various sets of circumstances and in its many ramifications. Any reader of his letters is delighted by the many images he uses to transmit his message, which are very helpful for the reader to be close of Paul himself.

1. Usage of metaphorical speech by the first Christians. Marriage, which is essential to God's plan of happiness, was instituted among our first parents, Adam and Eve, even before the Fall. [1] In every dispensation since, prophets bearing the holy priesthood have taught God's eternal plan and have been witnesses to the central nature of marriage and the family in that plan. One of those prophets was Paul. During his ministry in the meridian of times, Paul encountered a Church membership that was changing with the influx of Gentile converts. These converts, many of whom were Greek, had been reared in a morally corrupt society and were often undisciplined.

Paul's letter to the Ephesians was divided into two parts: the first three chapters addressed doctrinal issues while the rest dealt with the practical matters. Just like in the letter to the Ephesians, he opened the letter to the Colossians with thanksgiving and prayer. He then cut immediately to the heart of the matter and addressed the gradual mix of pagan teachings and philosophies with Christian beliefs. Just like in other epistles, he had to address the issue of legalism and reiterated that Christ had died to set them free. He ended the epistle with reminders on how to live properly and how to deal with other people. Philemon.

Jews and Gentiles. Especially in the protestant tradition-and particularly among Lutherans-it is Paul's Epistle to the Romans which holds a position of honor, supplying patterns of thought that are lifted into position of overarching and organizing principles for the Pauline material. Paul's presentation of justification by faith has such a role; to some this serves not only as the key to Pauline thought, but as the criterion for the really true gospel as it is to be found in the whole New Testament, the whole Bible, and the long and varied history of Christian theology. Yet the question arises: How can letters which Paul directed to specific churches in specific situations be the word of God for the church at large and in all times? The seventh chapter of Paul's first letter to the Corinthians is one of the most influential discussions of marriage and celibacy in the Christian tradition. Not only is it the most extensive treatment of these topics in the New Testament, but in the centuries following its appearance its importance grew to such an extent that one leading church historian has called it "the one chapter that was to determine all Christian thought on marriage and celibacy for well over a millennium."
