The Clinton administration did not initially make Israeli-Palestinian peace a priority. Clinton and his advisors believed that a diplomatic breakthrough on the Israeli-Syrian track would be more likely, and that Israelâ€™s leaders would find it politically easier to pull back from the Golan Heights than to withdraw from the West Bank.Â Worried that the peace process might collapse, the Clinton administration involved itself more actively in Israeli-Palestinian negotiations. In January 1997, following intensive U.S. mediation, Israel and the PA signed the Hebron Protocol, which provided for the transfer of most of Hebron to Palestinian control.
