They conflict most often because morality gives you a sense of what is right and wrong or acceptable and what is not according to human nature. Law commands obedience not out of a sense of right or wrong but out of necessity. For example, if a criminal lawyer who is defending an accused person who has raped and killed a teenager has a duty to the accused person (criminal, prisoner).<sup>4</sup> So I am disputing your major premise, that laws and morality are always in conflict.
